

## **City of Vergennes Parks & Recreation**

WHAT IS THE City of Vergennes PARKS AND RECREATION SCHOLARSHIP? The City of Vergennes Parks and Recreation Department maintains a Scholarship Fund for youth and adults who are Vergennes Area Residents that do not have the financial means to participate in fee-based recreational programs and activities.

WHO IS ELIGIBLE? Residents who are experiencing financial difficulty or who are in a unique, hardship situation are eligible to apply for a scholarship. We understand that from time-to-time families may encounter some unforeseen and unfortunate circumstances, emotionally or financially. During these times this program may provide some financial assistance to help the family meet some recreational needs. If you feel you are in need of assistance, but do not meet the income guidelines, please attach a letter to your registration form stating your circumstances. These are special circumstances and will be handled on a case-by-case basis. Depending on availability of scholarship funds, families may or may not be awarded a scholarship for two or more consecutive years.

**HOW DOES THE SCHOLARSHIP PROGRAM WORK?** Approved individuals or families will be awarded in 25%, 50% or 75% increments, not to exceed \$200 per year. The remaining balance shall be paid by the applicant. Once the necessary paperwork is completed for eligibility, it will stay on file for one calendar year. Applications will continue to be accepted until available scholarship funding is exhausted for the year. Scholarships will be awarded on a first-come, first serve basis while funding is available.

WHICH PROGRAMS CAN I USE THE SCHOLARSHIP FOR? All City of Vergennes sponsored programs. Scholarships cannot be used toward facility rentals, daily fees, or certain "co-sponsored" programs.

**WHAT SUPPORTING DOCUMENTATION IS NEEDED?** Proof of income and residency documents are REQUIRED. Incomplete applications will not be considered for scholarship funding.
